

FACTS	WHAT DOES ALOHA PACIFIC FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and account balances account transactions and payment history credit scores and credit history
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Aloha Pacific Federal Credit Union chooses to share; and whether you can limit this sharing.

Definitions	
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include financial companies, such as CU Cooperative Systems Inc., CUSO of Hawaii Investments LLC, CUSO of Hawaii Properties, LLC dba Aloha Pacific Premier Realty, CUSO of Hawaii Services LLC, HICUSO LLC.
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. Aloha Pacific Federal Credit Union does not share with our nonaffiliates so they can market to you.
Joint Marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include insurance companies.
